FLORIDA POWER AND LIGHT COMPANY'S
MOTION TO ACCEPT LATE FILING OF HEDGING INFORMATION REPORT

Florida Power & Light Company ("FPL"), by and through counsel, moves the Florida Public Service Commission ("Commission") to accept the late filing of FPL's Hedging Information Report. As grounds for its motion, FPL states as follows:

1. Pursuant to Order No. PSC-08-0316-PAA-EI, FPL's Hedging Information Report was due by Saturday, August 15, 2009. The Report was timely prepared for filing and was scheduled for hand delivery to the Commission on the afternoon of Friday, August 14, 2009. Although the messenger who was to deliver the Report for filing left in a timely fashion and should have been able to file the Report as scheduled, he was unexpectedly delayed en route to the Commission and was unable to reach the Commission Clerk's office before it closed for the day. Accordingly, FPL is filing the Hedging Report and accompanying Request for Confidential Classification of Certain Information Contained in the Fuel Hedging Information Report contemporaneously with this Motion on the morning of Monday, August 17, 2009.

2. The inadvertent late filing was not done for purposes of delay, and no party will be prejudiced by the brief delay in filing. All parties listed on the Certificate of Service for the
