**OBJECTIONS OF RICHARD UNGER TO FLORIDA POWER & LIGHT  
COMPANY'S NOTICE OF TAKING DEPOSITION**

Mr. Richard Unger hereby objects to Florida Power & Light Company's (FPL) Notice of Taking Deposition filed on August 14, 2009 and states the following:

1. Mr. Unger is a "regular" citizen of the state of Florida and a customer of FPL who wishes his voice to be heard on this matter through a representative.
2. Mr. Unger is not an expert on regulatory matters.
3. Mr. Unger is not filing testimony in this case, nor will there be testimony filed on his behalf. Therefore, FPL's deposition will not serve to aide in cross examination.
4. Mr. Unger's basic position in this matter is that FPL's request for a rate increase is not fair and should not be granted.
5. The deposition of Mr. Unger cannot reasonably be calculated to lead to admissible evidence in this matter.
6. If FP&L is allowed to depose an average citizen like Mr. Unger, other citizens of Florida, faced with the prospect of a billion dollar corporation showing up at their door with a tape recorder and a document from the government instructing them to answer questions, will surely shy away from a process that affects million of people.

Therefore, Mr. Unger respectfully requests that this commission deny FPL's request for a deposition.
