REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION

Florida City Gas ("Petitioner," "FCG," or "the Company"), by and through its undersigned counsel, and pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, hereby requests an extension of confidential classification granted to certain material (Document Nos. 08291-07 and 11100-07) that was previously provided to the Florida Public Service Commission ("Commission," "PSC," or "Staff") in connection with FCG's Purchased Gas Adjustment ("PGA") Audit for the Year Ended December 31, 2006 (Audit No. 07-067-4-1). In support of this Request, FCG states as follows:

1. By Order No. PSC-08-0150-CFO-GU, issued March 12, 2008, in Docket No. 080003-GU, the Commission granted FCG's request for confidential treatment of the information included in the referenced documents for a period of 18 months. By the terms of the Commission's Order, the confidential treatment afforded this information is set to expire on September 12, 2009, unless an extension of confidential treatment is approved.

2. Subsection 366.093(1), Florida Statutes, provides that upon request, records received by the PSC which are "found by the commission to be proprietary confidential business information shall be kept confidential and shall be exempt from s. 119.07(1)."

3. "Proprietary confidential business information" is defined as meaning "information, regardless of form or characteristics, which is owned or controlled by the ... company, is intended to be and is treated by the ... company as private in that the disclosure of the information would cause harm to the ratepayers or the company's business operations, and

has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public." § 366.093(3), Fla. Stat.

4. Proprietary confidential business information includes information concerning "contractual data, the disclosure of which would impair the efforts of a public utility or its affiliates to contract for goods or services on favorable terms." § 366.093(3)(d), Fla. Stat.

5. The designated portions of the information provided to, and retained by, the Commission fall within these statutory definitions, and therefore constitute proprietary confidential business information entitled to protection under Section 366.093 and Rule 25-22.006. The audit workpapers contain information, including specific contractual information, prices, and pricing data, which has been treated by FCG as private and has not been publicly disclosed. These terms and data, if disclosed, would impair the efforts of FCG to contract for goods or services on favorable terms in the future. The contractual terms and pricing data therein is therefore proprietary confidential business information and is entitled to continued and ongoing protection under Section 366.093 and Rule 25-22.006.

6. Specifically, FCG seeks continued confidential treatment of specific information as set forth in Attachment A, which is a duplicate of the original justification matrix provided to the Commission with FCG's original request for confidential treatment of this information on December 20, 2007. FCG further incorporates by reference the highlighted and redacted exhibits attached to its December 20, 2007, Request.

7. Pursuant to Section 366.093(4), Florida Statutes, and Rule 25-22.006(9), Florida Administrative Code, FCG requests that the information described above as proprietary confidential business information be protected from disclosure for a period of at least 18 months

and that all information be returned to FCG as soon as the information is no longer necessary for

the Commission to conduct its business.
