# JOINT REPORT AND MOTION TO DISSOLVE LIMITED STAY OF PROCEEDINGS AND SCHEDULE A RESPONSIVE PLEADING DATE

DeltaCom, Inc. ("DeltaCom") and Hypercube, LLC, Hypercube Telecom, LLC (f/k/a KMC Data, LLC) (collectively "Hypercube") (DeltaCom and Hypercube are hereinafter collectively, the "Parties") hereby report status of negotiations to and move the Florida Public Service Commission ("Commission") to lift the limited stay of the proceedings in this case. As grounds for this motion, the Parties state the following:

- 1. On June 5, 2009 DeltaCom filed a Petition with the Commission, naming Hypercube, LLC; Hypercube Telecom, LLC and KMC Data, LLC (collectively "Hypercube") as Defendants in an intrastate access charge dispute and seeking an order from the Commission. Thereafter, the Parties entered into discussions to resolve the dispute.
- 2. On June 26, 2009, DeltaCom, with support from Hypercube, filed a Motion for Limited Stay of this proceeding so that DeltaCom and Hypercube could undertake additional good faith negotiations in an effort to resolve the issues presented in DeltaCom's Petition without the need for litigation.
