PEF'S SEVENTH NOTICE OF INTENT TO REQUEST
CONFIDENTIAL CLASSIFICATION

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of the document produced in PEF's Supplemental Response to the Florida Public Service Commission's Staff's ("Staff") Twentieth Set of Interrogatories (Nos. 258-261), specifically number 259. The document being provided in response to this request contains confidential information relating to the Company's competitive interests, the release of which would harm the Company's competitive business interests. Specifically, this document is a grant application PEF has submitted to the federal government under the Recovery Act, which contains confidential and sensitive business information. For these reasons, PEF requests that the Commission afford this document confidential classification.
