This letter is to notify the Commission that Madison River Communications, LLC (Madison River) has filed with the Secretary of State to do business as "CenturyLink", so that its certificated name will now be Madison River Communications, LLC d/b/a CenturyLink. A copy of the relevant document reflecting this change is attached. Madison River requests that its CLEC Certificate No. 5254 and its IXC Registration No. TJ409 (former Certificate No. 7582) be changed to reflect the new d/b/a.

This name change is in conjunction with the merger of Embarq Corporation with CenturyTel, Inc., approved by the Commission in Order No. PSC-09-0126-PAA-TP (and consummated by Order No. PSC-09-0194-CO-TP). The market launch of the new company is anticipated to occur in mid-October, at which time Madison River will begin using the new name publicly. Madison River has provided notice to its customers of its new name. In addition, Madison River will update the cover pages of its tariffs to reflect the d/b/a in accordance with the Commission's requirements.
