This letter is to notify the Commission that CenturyTel Long Distance, LLC (CenturyTel Long Distance) has filed with the Secretary of State to do business as "CenturyLink Long Distance", so that its registered name will now be CenturyTel Long Distance, LLC d/b/a CenturyLink Long Distance. A copy of the relevant document reflecting this change is attached. CenturyTel Long Distance requests that its IXC Registration No. TJ994 be changed to reflect the new d/b/a.

This name change is in conjunction with the merger of Embarq Corporation with CenturyTel, Inc., approved by the Commission in Order No. PSC-09-0126-PAA-TP (and consummated by Order No. PSC-09-0194-CO-TP). The market launch of the new company is anticipated to occur in mid-October, at which time CenturyTel Long Distance will begin using the new name publicly.
