


4. Specifically Safelink seeks confidential classification of the document titled “Confidential Safelink Enrollment Process” and “Confidential Training Document”.

This information contains proprietary confidential business information pertaining to the enrollment procedures used by the company in processing applications for its Safelink Lifeline program as well as the training provided by the company to its customer service representatives. Such information is owned by Safelink, treated by the company as private, and its disclosure to third parties would cause harm to the company’s business operations. Moreover, Safelink derives economic value from this information not being generally known to, and not being readily ascertainable by competitors who can obtain economic value from its disclosure.

WHEREFORE, based on the foregoing, Safelink respectfully requests that this Commission enter an Order declaring the information described above as exempt from public disclosure pursuant to sections 364.183(3), Florida Statutes for a period of 18 months.
