Specifically, portions of PEF's response to Staff's Data Request, Attachment B, contains sensitive business information concerning negotiated capacity payments and negotiated energy payments, the disclosure of which would impair the efforts of the Company to negotiate contracts on favorable terms. If renewable producers were allowed to compare the rates being negotiated, it could lead to adverse effects for the Company, causing an increase in purchase power contract rates.
