On behalf of Progress Energy Florida, Inc. ("PEF") and Withlacoochee River Electric Cooperative, Inc. ("WREC"), the parties wish to provide additional clarification to information provided in paragraphs 4 and 7 of the joint petition to amend the territorial agreement between WREC and PEF approved by the Commission per Order No. PSC-06-0202-PAA-EU on March 14, 2006. The joint petition speaks to boundary modification in four areas to resolve outstanding issues between WREC and PEF.

PEF and WREC wish to clarify information provided in the above stated petition. The number of customers that were to be transferred in Pasco County under the existing agreement and that will not be transferred if the petition is approved is 117. This is a correction to the 115 customers indicated in the joint petition in item number 4. These 117 customers are identified in Exhibits A, C-2, and D-2, and include the two customers in Pasco County identified in item number 7 of the petition. The 33 customers discussed in item number 4 were transferred to WREC subsequent to the filing of the petition and are not a part of the 117 customers referenced here.

Additionally, the three boundary modifications identified in the petition are in Pasco and Hernando Counties. The petition states these modifications all occur in Pasco County.
