This Turbine Purchase Agreement ("Agreement") dated this 21 day of December, 2007, is entered into by and between <u>Tampa Electric Company</u> (the "Buyer"), a corporation organized and existing under the laws of Florida and having its principal place of business at 702 North Franklin Street, Tampa, Florida 33602, and the "Seller"), a corporation organized and existing under the laws of the State

1 DEFINITIONS

"Emissions Guarantee" means a guarantee by Seller that during the Emissions Test, the Equipment will only produce emissions in accordance with the criteria provided in Exhibit 4.

"Emissions Test" means a test to be conducted by Seller to determine satisfaction of the Emissions Guarantee.
