AMENDMENT TO

INTERCONNECTION AGREEMENT UNDER SECTIONS 251 AND 252 OF THE TELECOMMUNICATIONS ACT OF 1996

BETWEEN

BELLSOUTH TELECOMMUNICATIONS, INC. d/b/a AT&T FLORIDA

AND

FPL FIBERNET, LLC

The Interconnection Agreement dated February 27, 2007 by and between BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T") and FPL FiberNet, LLC ("CLEC") ("Agreement") effective in the State of Florida is hereby amended as follows:

- 1. The Parties agree that <u>AT&T-9STATE</u> shall be defined as the States of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
- 2. Section 12 of the General Terms and Conditions is amended by adding a new Section 12.4.1 following Section 12.4 as follows:
 - 12.4.1. In addition to the foregoing, the Parties agree that they may use Information for the limited purpose of discussions between AT&T and CLEC regarding a successor agreement to this Agreement.
- 3. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
- 4. In entering into this Amendment neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof.
- 5. This Amendment shall be filed with and is subject to approval by the Commission and shall become effective on the date of the last signature executing the Amendment.
