**REQUEST FOR CONFIDENTIAL CLASSIFICATION**

GULF POWER COMPANY ["Gulf Power", "Gulf", or the "Company"], by and through its undersigned attorneys and pursuant to Rule 25-22.006, Florida Administrative Code, hereby files a request that the Florida Public Service Commission enter an order protecting from public disclosure certain information submitted by Gulf Power in response to Commission Staff's Supplemental Data Request relating to Gulf Power's 2010 Ten-Year Site Plan. As grounds for this request, the Company states:

1. A portion of the information submitted by Gulf Power in response to questions numbered 4 and 34 of the Forecasting & Planning section, and question number 13 of the Renewable Energy section of Commission Staff's Supplemental Data Request constitutes proprietary confidential business information the disclosure of which would impair the competitive business of the provider of the information and Gulf's efforts to contract for goods and/or services on favorable terms. The information is entitled to confidential classification pursuant to section 366.093(3)(d) and (e), Florida Statutes. Specifically, the confidential information consists of a proprietary price deflator index developed by Moody's Economy.com and licensed to Gulf Power for use in developing energy price forecasts. This information is considered proprietary by Moody's Economy.com and is subject to non-disclosure obligations. Public disclosure of this information would impair Moody's Economy.com's position in the marketplace and cause Moody's Economy.com and other firms like it to refuse to enter into future contracts with Gulf, or charge higher prices, if these terms were made public.

2. The information filed pursuant to this Request is intended to be, and is treated as, confidential by the Gulf Power and, to this attorney's knowledge, has not been otherwise

publicly disclosed.
