We have reviewed the status of the documents that are subject to the Intervenors' pending Request for Official Recognition of Documents (the "Request"). The following documents included in Intervenors' Request were admitted as Exhibits during the evidentiary hearing on May 3, 2010 (the numeric references are to the paragraphs in Intervenors' Request):

- 4(b) GRU 2010 TYSP Petitioners stipulated to admission of this document as part of Exhibit 92;
- 4(f) May 11, 2008¹ Gainesville Sun article included in Exhibit 88;
- 4(e) (This should actually be paragraph 4(i).) Intervenors' Composite Exhibit of City Commission Chronology of Approval of Biomass Generator Petitioners stipulated to admission of only the summaries of the Minutes of City Commission Meetings on 1/28/08, 10/8/07, 3/24/08, 2/11/08, 4/28/08, 5/12/08 and 5/7/09 as part of Exhibit 92 (all other parts of this document have not been stipulated or otherwise admitted). Because the above-referenced documents have been formally admitted as exhibits in this proceeding, official recognition is not necessary and the Intervenors' Request with regard to these documents should be treated as moot.

The Intervenors' Request actually reference a May 12, 2008 Gainesville Sun article. We have confirmed with Intervenors that the May 12, 2008 reference was a scrivener's error and should have referenced a May 11, 2008 article.
