RE: Recommendation to Office of the General Counsel - Docket No. 100382-TL – Petition for expedited review of growth code denials by the Number Pooling Administration for the Orlando exchange by Embarq Communications, Inc..

On August 23, 2010, Embarq Communications, Inc. filed a request for additional numbering resources from the Number Pooling Administrator (NeuStar) for the Orlando exchange (ORLDFLERDS0) wire center. Embarq Communications requested a 407-NXX to meet the request of a specific customer for 8,000 consecutive numbers. On August 23, 2010, Embarq Communication, Inc. request for additional numbering resources was denied because it did not meet the utilization criteria.

On August 24, 2010, Embarq Communication, Inc. filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order No. PSC-01-1973-PCO-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the Embarq Communication, Inc. petition and has determined the following:

- 1) The carrier has demonstrated that it has customers in need of numbering resources;
- 2) The carrier has shown that it will be unable to provide services to these potential customers because of NeuStar's denial of the numbering resources; and
- 3) Customers will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three criteria of PSC-01-1973-PCO-TL have been met, please prepare an administrative Proposed Agency Action Order to be issued within seven business days of this memorandum (September 10, 2010), as outlined in the expedited code denial process order. NeuStar should be directed to provide Embarq Communication, Inc. the needed numbering resources to meet its customer's needs in the Orlando exchange (ORLDFLERDS0).
