At the August 3, 2010 agenda, the Commission requested that the Utility within sixty days collect water samples and conduct testing of primary and secondary standards to obtain more current test results for its Summertree water system. Samples have been collected and test results have been submitted to the Commission staff.

My review of the test results and comparison of those results to the maximum contaminant levels (MCLs) specified by the Department of Environmental Protection (DEP) shows that all contaminants are below the MCL. This means that all results are in compliance with DEP's rules. Test results have been compiled in the attached tables.
