## PEF'S TENTH NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006. Florida Administrative Code, files this Tenth Notice of Intent to Request Confidential Classification of the confidential portions of the Office of Public Counsel's Post-Hearing Statement of Positions and Post-Hearing Brief ("the Brief"). The Brief contains proprietary confidential business information related to the costs of the CR3 Uprate Project, including the License Amendment Request ("LAR"), and the Levy Nuclear Project ("LNP"), including costs related to the LNP EPC Agreement. These costs are incurred, in whole or in part, pursuant to PEF's contracts with third parties. These contracts contain confidentiality provisions forbidding the release of contractual terms, including pricing provisions. The disclosure of this information would harm PEF's competitive business interests by impeding the Company's ability to obtain such contracts, and would further violate the aforementioned confidentiality agreements. Furthermore, the Brief contains other proprietary confidential business information, including information related to the Company's internal assessment of risks. This information
