By Order No. PSC-10-0531-PCO-TP, issued on August 19, 2010, the Florida Public Service Commission ("Commission") granted staff's Unopposed Motion to Hold Time in Abeyance.

This memorandum is filed pursuant to the Prehearing Officer's direction, in that Order, that staff file a status update within thirty days of the Order and every thirty days thereafter.

On September 7, 2010, staff met with representatives of Associated Telecommunications Management Services, LLC ("ATMS") regarding staff subpoenas to ATMS companies. In this meeting, staff and ATMS agreed to the following.

While staff reserves the right to request such information in the future, and the ATMS companies reserve the right to object to such requests, staff withdrew requests to ATMS companies for non-Florida information, lists of employees, corporate minutes, copies of 499-A and 499-Q forms filed with the Universal Service Administrative Company, *Federal* Income Tax returns, and certain purchase agreements for specified corporations.

ATMS companies will respond to staff's subpoenas as set forth below to the extent that such information exists and is within their control. ATMS company responses will be provided as information is gathered, but in no case later than close of business on October 22, 2010, (45 days from September 7, 2010).
