

JOINT MOTION TO LIFT ABEYANCE AND CLOSE DOCKET

On November 19, 2009, the Commission granted the parties' Joint Motion to Hold Docket in Abeyance. (Order No. PSC-09-0785-PCO-TP ("Order").) The Commission stated that the abeyance would last until the parties or the Commission moved to lift it, or until the FCC disposed of the Verizon/Intrado arbitration of an interconnection agreement for Virginia. (Order at 1.)

Verizon and Intrado have negotiated an interconnection agreement that resolves all of the issues in this docket. That agreement was filed with the Commission in this docket on September 17, 2010. Verizon and Intrado, therefore, ask the Commission to lift the abeyance so that it can issue an order approving the interconnection agreement and closing the docket.
