This letter is a follow-up to my letter of October 6, 2010.

As previously stated, in addition to being a resident of Tamiami Village, I am a Director and Treasurer of Tamiami Master Association, Inc.

These letters are in reference to your recently published potential rate increases which, to me, seem excessive.

Phone calls were made to determine the rates of surrounding localities. Rates related were:

Questions:

- 1 In view of the charges of Lee County and Cape Coral, why do you on the Commission feel that even your "Interim" rates are proper and competitive?
- 2 Why do you on the Commission feel that we in Tamiami Village should be subject to these high rates?
- 3 Do you on the Commission feel it is appropriate that all proposed rates be so much higher? Or, how do you justify our rates being so much higher than our neighbors?
- 4 Who grants the authority of a company such as NI-Florida to service our community?
- 5 For what period of time does this "right" to service our community?
- 6 It is obvious from the extremely high requested increases that there is a high profit potential from this activity. Can you please tell me the steps that our park can take to negate this authority?
- 7 Could our park simply request some organization to come in at some agreeable rates or amounts to provide us with water? If not, why not?
- 8 Finally, will you please provide me with alternatives for us to take steps to obtain reasonable rates comparable to our neighbors?
