


Waiver of Sovereign Immunity

The law office of Rosado Law Firm, P.A., and The Law Office of Valencia Richards Hayes represent Holly Ford, the mother of the decedent, Cameron Ford.

This letter is hereby submitted, pursuant to Florida Statute-§768.28, to inform you that on behalf of our client, Ms. Holly Ford, individually and as the personal representative of the decedent, Cameron Ford, a claim of wrongful death is made against the city of Cape Coral, a subdivision of the State of Florida, for damages resulting in the wrongful death of Cameron Ford, the minor son of Holly Ford, resulting from the city's negligence.

The city of Cape Coral owns streetlights which it uses to illuminate the streets for roadside safety. The proper illumination of the streets allows drivers of motor vehicle to see, recognize other vehicles and pedestrians using the streets. The city of Cape Coral failed to properly maintain streetlights in the vicinity of Trafalgar Parkway and SW 6th Avenue, causing the street to be extremely dark which prevented Jacob York, the operator of a 1996 Ford SUV, from seeing the decedent, Cameron Ford, crossing the street with his bicycle, causing Jacob York to collide with Cameron Ford resulting in Cameron's death.
