I believe we have everything we need to process the application except for the proof of noticing. Rule 25-30.030, Florida Administrative Code requires notice to utilities when territory changes.

I have a copy of a document entitled, "Notice of Application for Amendment of Service Area," and the first sentence in the notice begins with Notice is hereby given on the \_\_\_\_\_ day of November, 2009.... Did this notice ever get sent? If so, I need an affidavit similar to the one you filed on July 26 for the tariff and annual report, that says you gave notice and to whom notice was given. If noticing still needs to be made, the folks to get notice are listed in the attached pdf. Notice can be by regular, first class mail.

In addition to the noticing described above, the utility should notify the all of its customers that the land swap occurred. A bill stuffer with a regular billing will suffice. The notice to the customers might best be understood if you described the land swap by referring to the subdivision name rather than the NU-1 and NU-2 description that I refer to in the preceding paragraph. For instance, you might want to refer to the added customers as "Those residents who live in \_\_\_\_\_\_ S/D on Cherokee Cove Drive; Cherokee Cove Trail, south of Cherokee Cove Drive; the ten easternmost lots on Arrowbrook Lane [or if you want to use addresses on Arrowbrook] are now customers of Neighborhood Utilities, Inc. Residents who live on a portion of Cherokee Cove Trail North, (a street east of Cherokee Cove Trail whose name is not listed on the map), Mistybrook Court, and east of Mistybrook on Cherokee Cove Trail North and Cherokee Trail Cove East are now served by JEA."

You will also need to notice the property owners in the territory you gained from JEA so that when homes are built, those folks will know that water service will come from Neighborhood. The folks who are already getting service from JEA do not need to be noticed. Once all the noticing is complete, you will need to include a statement in the affidavit mentioned in the second paragraph above that notice was given to existing customers and property owners who are affected by this territory addition.
