I would suggest that any discussion about any next steps that you may or may not have available to you not be made here in this forum. I don't think that the -- respectfully I don't think the Agenda Conference is the appropriate place to do that.

If procedurally you want to discuss the body's ability to move forward in any way and file anything in the First District Court of Appeal so it would not be in a Commission proceeding where you would be filing it, I think the more appropriate venue would be the Internal Affairs which you have scheduled later this afternoon.

And Samantha, we can have Samantha Cibula there who can help in any discussion with respect to how you may, if at all, go forward. Right now the jurisdiction does not rest with you. The jurisdiction over the matter is with the First District Court of Appeal.

CHAIRMAN GRAHAM: How would we go about contacting them if we wanted to, if we wanted to request this?

MS. HELTON: It would require a court filing. But I think this discussion would be much better had, for notice reasons, for process reasons, at the Internal Affairs meeting which is scheduled for later today.

CHAIRMAN GRAHAM: Okay. Well, I just wanted to bring it up here because this is where it's actually on our docket. So then at that point I guess we can say we're going to talk about it at

Internal Affairs.
