

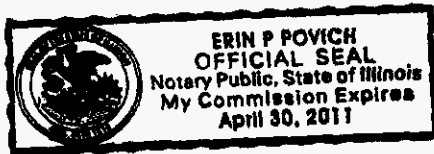

CUSTOMER NOTICE

ISSUED: November 24, 2010

Rates were last set for Mid-County Services, Inc. (the "Utility") in 2009 by the Florida Public Service Commission ("PSC"). The PSC Staff's review of the Utility's 2009 annual report revealed possible overearnings of approximately 1.92% of total revenues. The Utility entered into discussions with the PSC Staff and the Office of Public Counsel regarding these possible overearnings. On August 16, 2010, the Utility proposed a settlement offer in which it would (1) withdraw its 2010 index application, (2) refund the amounts collected under the 2009 index, (3) reduce rates by an across-the-board 1.92%. This totals \$35,842, which is slightly greater than the original 2009 price index increase, and (4) refund any incremental 2009 overearnings above the amount of the 2009 index.

By Order No. PSC-10-0680-PAA-SU, issued November 15, 2010, in Docket No. 100379-SU, the PSC approved the Utility's settlement offer and approved the reduced rates as detailed in the rate chart below (see next page).

The reduced rates and charges are effective for service on or after December 1, 2010.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
