



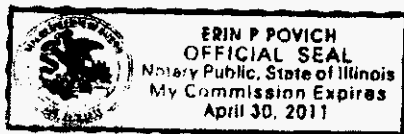

CUSTOMER NOTICE

ISSUED: December 13, 2010

On June 30, 2009, Cypress Lakes Utilities, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water and wastewater service rates, in which it requested a permanent increase for its water system of \$68,388 or 21.6% and a permanent increase for its wastewater system of \$238,907 or 43.2%, in Polk County.

By Proposed Agency Action Order No. PSC-10-0682-PAA-WS ("PAA Order"), issued November 15, 2010, the Commission approved a 17.24% rate increase for water service and an increase of 32.89% for wastewater service. These rates and charges were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service. Should the PAA Order be protested within the protest period, the Utility will collect the rates shown below subject to refund with interest pending the outcome of the protest.

The increased rates and charges are effective for service on or after December 18, 2010. The rates prior to filing and the Commission-approved water and wastewater rates are attached to this customer notice.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
