

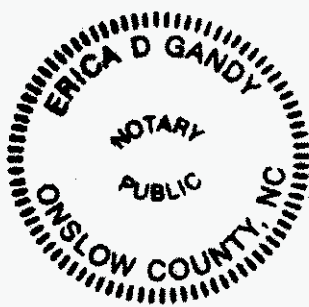

On December 20, 2010, the Florida Public Service Commission issued Order No. PSC-10-0735-TRF-WS, in Docket No. 100381-WS, approving a change to Pluris Wedgefield, Inc.'s ("Utility") Tariffs to allow it to collect a \$5.25 late payment fee where payment has not been received by the due date, and to collect miscellaneous service charges for connection and premises visit services, as noted below:

* *Please note: This schedule was revised so that connection and premises visit fees are the same for water or wastewater service. If you receive both water and wastewater service, you would only be charged once for connection and premises visit fees per visit.*

These miscellaneous service charges and late fees are effective for service on or after January 19, 2011.
