105. In response to data request number 100, Absolute stated an audit had been performed by USAC regarding Universal Service Funds in relation to TLS reimbursement and the results were pending. Have those results been released? What were the results of that audit?

RESPONSE: The results of 2010 Toll Limitation Service Support In-Depth Validation (IDV) Absolute Home Phones, Inc. (SAC 239019) have been released. The audit was closed stating that 6 subscriber lines were found to be ineligible for TLS and Absolute was requested to pay back \$19.00. However, Federal Universal Service Fund Low Income Program Payment Quality Assessment LI-2010-06-Case-164 was issued on January 24, 2011 and closed as no further action needed.
