The requested information concerning the retail rates is contained on the enclosed CD labeled "Staff Twenty Second Data Request Response." Attached hereto is the requested table of current purchased water and wastewater charges. Also see AUF's response to Staff Fifteenth Data Request, as well as the letter dated February 2, 2011 concerning the Lake Osborne water system.

- 5. In its response to the Lake Osborne Civic Association's letter, dated February 2, 2011, AUF also requested a pro form increase in purchased water for the Lake Osborne system. AUF also indicated that it is now being billed under multi-family rates, instead of general service rates pursuant to the original purchased water contract dated October 9, 1974. The original contract indicates that AUF will be billed at the general service rates. Please respond to the following:
 - a. Please provide any and all correspondence between AUF and Lake Worth Utilities Authority (LWUA) regarding the justification for switching AUF's customer class from general service to multi-family.
 - b. Please explain or describe whether AUF is actively pursuing that it remain a general service customer, instead of a multi-family customer with LWUA. If so, please provide the current status of the negotiations.

RESPONSE:

a. AUF and LWUA continue to exchange telephone calls and electronic mails (e-mails) concerning the current revision to the rate structure change. AUF respectfully believes it is inappropriate to submit internal e-mails with LWUA while negotiations are ongoing. AUF has requested the justification for the switch and a review of the appropriate rates and charges. LWUA has responded that they are conducting further investigation for the switch. Further, AUF is scheduled to meet with LWUA on February 28, 2011 for further discussions.

b. AUF is involved with on-going discussions and negotiations with LWUA concerning the appropriate bulk water rates which AUF should be charged. AUF is scheduled to meet with LWUA on February 28, 2011 for further discussions. Once these discussions are concluded, AUF will report back to the Commission on the progress and any resolutions.

AUF has calculated that if it is successful in reverting back to the General Service rates as agreed to in the 1974 agreement, the increase in purchased water expense will be \$63,597.85 through October 2011. See spreadsheet attached hereto.

Further, the impact of the General Service rates beginning in October 2011 forward will be \$79,004.
