Dear Larry,

The current schedule in FPSC Docket No. 110018-EU establishes the following events and dates: hearing on April 25th, post-hearing submittals (if any) by May 9th, Commission agenda on June 14th, and issuance of an Order on June 28th. Commission Rule 25-22.080, F.A.C., provides among other things that:

- (i) "... the Commission shall set a date for hearing, which shall be within 90 days of receipt of the petition ...";
- (ii) "... each party may make submittals to the Commission on a time schedule to be determined in accordance with the requirements of each proceeding, but terminating no later than 120 days from the receipt of the petition ..."; and,
- (iii) "The matter will be placed before the Commission on an agenda which will permit a decision no later than 135 days from the date of receiving the petition or the issuance of the order commencing the proceeding."

Based on the procedural orders and the current CASR in this proceeding, through no fault of the Commission, none of these three time limits will be met.

Joint Petitioner SWA hereby agrees to extend the applicable time limits specified in the rule to accommodate the currently-scheduled dates for the hearing, post-hearing submittals, Commission agenda, and issuance of an order as those dates are set forth above. Joint Petitioner FPL has no objections to this proposed extension of the applicable time limits.
