This correspondence is in response to Patti Daniel's April 14, 2011 letter to Dixon Pugh requesting certain information in connection with the above-referenced Application.

1. **Contract Transferring the Utility.** Neither Highlands Utilities Corporation ("HUC") or its attorneys have the requested signature pages executed on behalf of the Town of Lake Placid. We would suggest you contact Burt J. Harris, III who is the attorney for the City of Lake Placid and should have the executed signature pages.

2. **Closing Date.** The closing occurred on October 5, 2010.

3. **DEP/SFWMD Compliance.** Highlands Utilities Corporation was addressing a number of issues with DEP at the time of sale. The DEP had submitted a proposed Consent Order to HUC and then agreed to hold any enforcement action in abeyance pending the sale. Upon sale of the system to the Town of Lake Placid, the DEP issues became moot as to Highlands Utilities Corporation.


