**AMENDMENT  
TO THE  
PAGING AGREEMENT BETWEEN  
BELLSOUTH TELECOMMUNICATIONS, INC.  
d/b/a AT&T ALABAMA, AT&T FLORIDA, AT&T GEORGIA,  
AT&T KENTUCKY, AT&T LOUISIANA, AT&T MISSISSIPPI,  
AT&T NORTH CAROLINA, AT&T SOUTH CAROLINA  
AND AT&T TENNESSEE  
AND  
TRACI COMMUNICATIONS**

Pursuant to this Amendment, BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina And AT&T Tennessee (AT&T) and Traci Communications (Traci Communications), hereinafter referred to collectively as the "Parties", agree to amend that certain Paging Agreement between the Parties dated May 3, 2006 ("Agreement") to be effective the date of the last signature.

**WHEREAS**, Traci Communications has changed the name of said business to Traci.net, Inc. d/b/a Traci.net (Traci.net, Inc. d/b/a Traci.net), and shall apply to the State of Florida.

**WHEREAS**, the Parties desire that the Paging Agreement be amended to reflect the correct corporate entity name.

**NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties agree that AT&T-9STATE shall be defined as the States of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
2. The name of Traci Communications in the Paging Agreement is hereby deleted throughout the Paging Agreement and replaced with Traci.net, Inc. dba Traci.net.
3. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
4. All of the other provisions of the Paging Agreement, dated May 3, 2006, shall remain in full force and effect.
5. Either or both of the Parties is authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
