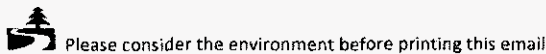

FPL Response to Audit Finding No. 1

As part of the permitting and licensing effort for the Turkey Point 6 & 7 project, key members of the FPL New Nuclear team are required to attend Miami-Dade County agency meetings. In accordance with the Miami-Dade County Code, such activity requires registration as a "lobbyist". Similar activity with other agencies and counties does not require such registration. Based on FPL's experience, the classification of this precondition to attendance at the county agency meetings as "lobbying" is unique to the Miami-Dade County Code, and is not the type of political lobbying that would be inappropriate to include in project expenditures. Clearly, this activity is necessary to successfully obtain the licenses and approvals needed for the Turkey Point 6 & 7 project. However, to avoid the cost of further debate over this item, for the purpose of this proceeding only, the company has voluntarily performed a reclassification of the charges by crediting the Nuclear Cost Recovery Clause account. As such, the Company is willing to consent to the removal of the charges from the NFR schedules.
