(PEF), I am writing to advise that, at this time, PEF has identified no new environmental projects for which it plans to seek initial cost recovery approval in this docket, other than those activities identified in the petitions that PEF filed on March 11, 2011, regarding new NPDES renewal permits and on May 24, 2011, regarding activities associated with EPA's development of new air emission standards. PEF does anticipate that it will incur costs in 2012 for new activities associated with PEF's Integrated Clean Air Compliance Plan and new cooling water intake requirements currently under development. However, the scope and potential costs of such activities have not been determined at this time. PEF will address all such new activities in future filings at the appropriate time.
