RE:	Docket No. 110150-TI - Compliance investigation of IXC Registration No. TK084, issued to Dinamica Telecom, Inc., for apparent first-time violation of Section 364.336, F.S., and Rule 25-4.0161, F.A.C., Regulatory Assessment Fees; Telecommunications Companies.

On June 17, 2011, Proposed Agency Action Order No. PSC-11-0260-PAA-TI was issued in this docket advising Dinamica Telecom, Inc. (Dinamica) of its apparent first-time violation of Section 364.336, Florida Statutes and Rule 25-4.0161, Florida Administrative Code, *Regulatory Assessment Fees.* In the Order, Dinamica was requested to pay the outstanding RAF fees, penalties, and costs. The Order also stated that staff would refer Dinamica to the Florida Department of Financial Services for further collection efforts if it failed to pay the outstanding fees and costs.

On July 8, 2011, Andrew S. Bisom, attorney representative for Dinamica, submitted a copy of the October 21, 2010 Bankruptcy filing for Dinamica.

On July 11, 2011, Consummating Order No. PSC-11-0299-CO-TX was issued in this docket. The Consummating Order finalized Proposed Agency Action Order No. PSC-11-0260-PAA-TI authorizing the Commission to collect the outstanding fees and costs or refer Dinamica to the Florida Department of Financial Services for further collection efforts.

Pursuant to 11 USCS § 362 (a) (1) and (a) (2) of the US Bankruptcy Code, the filing of a petition for bankruptcy relief acts as a stay to an administrative action or proceeding against the debtor that was or could have commenced before the bankruptcy proceeding. The bankruptcy filing also acts as a stay to enforcing a judgment obtained against the debtor before the bankruptcy action.<sup>1</sup>

Dinamica Telecom, Inc.'s bankruptcy filing acts as a stay to any administrative proceedings including this compliance investigation. Since the Commission is prohibited from taking further agency action against the company at this time, Docket No. 110150-TI should be closed. OK to close
