### NEW TALK, INC.'S REQUEST FOR DEFERRAL

New Talk Inc. (New Talk) hereby files this request for deferral of the recommendation filed in this docket on September 8, 2011 and scheduled to be considered by the Commission at its August 20<sup>th</sup> Agenda Conference. As grounds therefor, New Talk states:

1. On August 9, 2010, New Talk filed a request to transfer its CLEC certificate to Telecom Ventures, LLC.

2. On January 12, 2011, Commission Staff filed a recommendation recommending approval of the transfer and putting this item on the Consent Agenda for the January 25<sup>th</sup> Agenda Conference. One day before the January 25<sup>th</sup> Agenda Conference, AT&T Florida (AT&T) filed an objection to the transfer and the item was deferred.

3. On February 9<sup>th</sup>, New Talk responded to AT&T's objections.

4. No further docketed activity has occurred in this matter since February 9, 2011,

until Staff filed a recommendation on September 8, 2011.

5. The recommendation not only recommends that the request for transfer be denied, but also recommends the drastic action of cancellation of New Talk's CLEC certificate.

6. New Talk believes that many of the allegations in Staff's recommendation are factually inaccurate and/ or incomplete.<sup>1</sup> New Talk would like to have the opportunity to meet

with Staff and discuss some of the issues in the recommendation and hopefully come to a resolution of these matters.

7. There is no prejudice to anyone due to a deferral of this item, as the status quo will remain in place.

8. Staff supports this deferral request.

WHEREFORE, New Talk requests that this item be deferred until Staff and New Talk

have an opportunity to meet to discuss (and hopefully resolve) Staff's concerns.
