Staff has reviewed the above-referenced application filed by Brendenwood Utilities, LLC (applicant) on behalf of Brendenwood Water System Inc. (Brendenwood or Utility) and determined that the following information is necessary to clarify the application.

Additional Information

1. Rule 25-30.037(2)(j), Florida Administrative Code (F.A.C.), requires that the application include a statement indicating how the transfer is in the public interest, including, among other things, a showing of the buyer's financial ability to provide service. Staff has reviewed the applicant's response to this rule requirement. Please provide a showing of the applicant's financial capability to provide service, such as a personal financial statement or tax return.
2. Rule 25-30.037(2)(o), F.A.C., requires that the application include a statement from the applicant that it has obtained or will obtain copies of all of the federal income tax returns of Brendenwood from the date the Utility was first established or the date rate base was last established by the Commission or, if the returns have not been obtained, a statement detailing the steps taken to obtain them. Staff has reviewed the applicant's response to this rule requirement. Please provide the approximate date by which the applicant expects to obtain the tax returns from Brendenwood.
