2	COMMISSIONER EDGAR: We will look at the move
3	staff list, and we are going to do it just a little bit
4	differently. What I'm going to do right now is call
5	Item 1, which is the minutes.
6	COMMISSIONER BROWN: Madam Chairwoman, I have
7	one modification to Item 7 on the Minutes of Commission
8	Conference, August 23rd, 2011. Under the decision
9	area, it says the recommendations were approved with a
10	modification to Issue 10 to disallow legal fees and
11	miscellaneous expenses associated with the litigation,
12	noting that the utility did not
13	COMMISSIONER EDGAR: Commissioner Brown, I'm
14	so sorry, can you point us to a page number?
15	COMMISSIONER BROWN: Oh, my apologies. 17.
16	COMMISSIONER EDGAR: Thank you. Okay. Go
17	right ahead.
18	COMMISSIONER BROWN: Under decision I'll
19	just repeat myself it says the recommendations were
20	approved with the modification to Issue 10 to disallow
21	the legal fees and miscellaneous expenses associated
22	with the litigation, noting that the utility did not
23	have the correct insurance to cover the costs. I think
24	the words that would be more appropriate are for
25	correct insurance or necessary or appropriate. That, I

believe, captures the discussion on the issue, rather than the word correct. So I would amend that correct insurance to be necessary or appropriate insurance. And with that, I would move the minutes, with that modification.

So just so I'm 6 clear, on Page 17 of the minutes for August 23rd, Item 7 7, Commissioner Brown has made the motion that in -- at 8 the bottom of the page on the decision portion that the 9 10 language in the parens would be changed to say, "Noting 11 that the utility did not have the necessary as appropriate insurance to cover the cost." Is that 12 correct? 13

14 COMMISSIONER BROWN: Necessary or15 appropriate.

16 COMMISSIONER EDGAR: Necessary or
17 appropriate. Thank you. If I could read my own
18 writing, that would help.

Commissioners, any questions about that
requested change to the minutes, to the draft
minutes? No questions. Okay.

Then Commissioner Brown has made a motion for a change, a slight modification to the language for the minutes of August 23rd, and to approve all other of those minutes as they are presented before

1 us. Is there a second? 2 COMMISSIONER BALBIS: Second. 3 COMMISSIONER EDGAR: Okay. Then all in favor 4 of approving the minutes as modified for August 23rd 5 6 say aye. (Vote taken.) 7 **COMMISSIONER EDGAR:** Show it adopted. And 8 then if I could have a motion to approve the minutes 9 for August 9th. 10 COMMISSIONER BRISÉ: I move the minutes for 11 12 August 9th. COMMISSIONER EDGAR: Is there a second? 13 COMMISSIONER BALBIS: Second. 14 COMMISSIONER EDGAR: All in favor say aye. 15 (Vote taken.) 16 COMMISSIONER EDGAR: Thank you. That takes 17 up Item 1. 18 19 COMMISSIONER EDGAR: And then, Chairman 20 Graham, we did take up approval of the minutes 21 separately, and I believe Commissioner Brown made that 22 23 motion. So I'm going to look to Commissioner Brown to consider a reconsideration motion. 24 COMMISSIONER BROWN: Yes. I move to 25 FLORIDA PUBLIC SERVICE COMMISSION

1 reconsider the motion on the minutes.

COMMISSIONER EDGAR: And we did take that up 2 as two separates votes on August 9th and August 23rd, 3 but for these purposes I think we can combine them. So 4 we have a motion. Do we have a second? 5 COMMISSIONER BALBIS: We have a second. And 6 I assume that the reconsideration will include the same 7 revision that Commissioner Brown indicated. 8 COMMISSIONER EDGAR: It will, but right now 9 we are just reconsidering. 10 COMMISSIONER BALBIS: Then I second. 11 **COMMISSIONER EDGAR:** Thank you. (Laughter.) 12 All in favor of reconsidering the motions 13 for approval of the minutes for August 9th and 14 15 August 23rd say aye. (Vote taken.) 16 COMMISSIONER EDGAR: All opposed? 17 18 Show it adopted. Commissioner Brown. 19 COMMISSIONER BROWN: And this is for Mr. 20 21 Chairman's pleasure, leisure, information. I made a modification to the minutes of August 23rd, 2011, for 22 Item 7 on Page 17. And I moved to amend under the 23 decision, the recommendations were approved with the 24 modification to Issue 10 to disallow the legal fees and 25

COMMISSIONER BALBIS: Second. 11 COMMISSIONER EDGAR: All in favor say aye. 12 (Vote taken.) 13 COMMISSIONER EDGAR: All opposed? 14 Show it adopted. 15 Chairman Graham, back to you. 16 CHAIRMAN GRAHAM: That's it. I just wanted 17 to say thank you. Of course, I was probably okay with 18 not the approval of the minutes, but, ah. (Laughter.) 19 Commissioner Edgar, I want to thank you 20 for taking over for me this morning. You know how 21 22 these things are from time to time, you get summoned over to the capital, and I was glad that I went, and 23 I look forward to discussing in IA some of the 24 details of some of the stuff we went over. 25
