C. STATEMENT OF BASIC POSITION

PGS's Statement of Basic Position:

The Commission should approve PGS's final PGA true-up amount of \$9,599,007 (underrecovery) for the period January 2010 through December 2010; its actual/estimated PGA true-up amount of \$11,966,268 (overrecovery) for the period January 2011 through December 2011; and its levelized PGA (cap) factor of \$0.99606 per therm for the period January 2012 through December 2012. (Floyd)

D. STATEMENT OF ISSUES AND POSITIONS

Generic Purchased Gas Adjustment Issues

ISSUE 1: What are the final purchased gas adjustment true-up amounts for the period January 2010 through December 2010?

PGS: \$9,599,007 underrecovery (Floyd)

ISSUE 2: What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2011 through December 2011?

PGS: \$11,966,268 overrecovery (Floyd)

ISSUE 3: What are the total purchased gas adjustment true-up amounts to be collected during the period January 2012 through December 2012?

PGS: \$2,367,260 overrecovery (Floyd)

ISSUE 4: What are the appropriate levelized purchased gas cost recovery (cap) factors for the period January 2012 through December 2012?

PGS: \$0.98437 per therm (Floyd)

<u>ISSUE 5</u>: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

PGS: The charge should be effective beginning with the specified purchased gas cost recovery cycle and thereafter for the period January 2012 through December 2012. Billing cycles may start before January 1, 2012, and the last cycle may be read after December 31, 2012, so that each customer is billed for twelve months regardless of when the adjustment charge became effective. (Floyd)

ISSUE 6: What changes, if any, should be made to improve the reporting mechanism relating to monthly PGA reporting established in Order No. 24463?

<u>PGS</u>: PGS agrees with the position set forth in the Commission Staff's Prehearing Statement. (Floyd)
