As promised at the November 15, 2011, meeting in this Docket, Florida Public Utilities Company ("FPUC") submits this letter to report on the current status of discussions between FPUC and Peoples Gas System ("Peoples")(herein jointly referred to as "Companies") regarding the development of a Territorial Agreement to better define the Companies' respective areas of service in Nassau and Duval Counties. Having conferred with counsel for Peoples in this regard, I am able to report that, consistent with the Letter of Intent between the Companies, documents have either been drafted, or are in the process of being drafted, which will memorialize agreements between FPUC, Peoples, and Peninsula Pipeline for service in these Counties. These draft documents include a Territorial Agreement to be submitted to the Commission for approval at the appropriate time.

Again, the Companies continue to make progress in the development of these documents, which will ultimately provide clarity as to each Company's respective service area. However, in view of the intervening holidays, it is unlikely that we will be able to submit an executed Territorial Agreement for Commission approval prior to mid-January 2012.
