BellSouth Telecommunications, LLC d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, files its Request for Specified Confidential Classification.

1. On November 28, 2011, AT&T Florida filed its Motion to Dismiss and Response to FLATEL, Inc.'s ("FLATEL") Complaint ("Motion") in the captioned docket, along with a Notice of Intent for Exhibit C, attached to AT&T Florida's Motion.

2. AT&T Florida hereby files this Request for Specified Confidential Classification because the Confidential and Proprietary Exhibit "C" attached to AT&T Florida's Motion contains information that might be considered confidential business information to FLATEL. A more specific description of this information is contained in Attachment A.

3. The information discussed in the Request for Specified Confidential

Classification, upon information and belief, is confidential to FLATEL and related to its competitive interests. Therefore, such information should be classified as confidential business information pursuant to Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.
