#### JOINT STIPULATION

The County of Volusia (hereafter referred to as the "the County") and Farmton Water Resources, LLC (hereafter referred to as "FWR") jointly stipulate to the amendment of FWR's wastewater certificate application before the Florida Public Service Commission and the withdrawal of the County's objection thereto and further state:

WHEREAS, FWR filed an application for a wastewater utility certificate with the Florida Public Service Commission on October 27, 2011, and;

WHEREAS, the County filed a timely objection in the above styled matter to FWR's certificate application, and;

WHEREAS, the parties wish to enter into a stipulation which will result in a withdrawal of the County's objection.

## **STIPULATION**

1. FWR agrees that the complete pleadings, application, engineering report, and all documents filed with the Public Service Commission for a wastewater certification in Docket Number 11-0298-SU are amended to redact and remove any reference to Volusia County, except to the extent that any reference to Volusia County may serve to explain the proposed certification of lands in Brevard County, to remove all lands within the boundarles of Volusia County and to remove all calculations utilized for need which include density or

intensity of all potential development in Volusia County.

2. The application in Docket Number 11-0298-SU applies only to Brevard County.

3. FWR agrees that any request for a wastewater utility certificate on lands and/or for development within the jurisdiction of Volusia County shall require an entirely new and separate certificate application, including a new notice of a wastewater certificate application before the Public Service Commission.

4. The parties agree this settlement clarifies all lands within Volusia County have been removed from the proposed wastewater service area and that the proposed wastewater certification is strictly for a proposed service area in Brevard County.

5. Based on FWR's stipulation herein, the County agrees to withdraw its objection to FWR's wastewater certificate and restrictive amendment in Docket Number 11-0298-SU.

6. The parties to this agreement have consulted with counsel and give assurances that the signatories to this document have the necessary authority to bind the parties to the terms stipulated to herein.

7. The effective date of this Joint Stipulation shall be the date upon which last

party signs.
