- Form new concrete slab poured 6" thick with 3000psi RR mix with rebar reinforcement.
- Supply and install new quad high service premium efficiency pump package 240volt 3phase 3,500rpm as follows:
  - -(2) High Service Pumps 20hp ODP rated 300gpm @ 160' TDH
