**THE FLORIDA INDUSTRIAL POWER USERS GROUP'S
UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE BRIEF**

The Florida Industrial Power Users Group (FIPUG), pursuant to rule 28-106.204, Florida Administrative Code, files this unopposed motion for a short extension of time, until noon on March 5th, to file its post-hearing brief in this matter. As grounds therefor, FIPUG states:

1. The Order on Procedure in this case, Order No. PSC-11-0565-PCO-EI, directs the parties to file post-hearing briefs on March 2, 2012.

2. The Florida legislative session comes to a close next week. Activity at the Legislature has intensified as the end of the session nears. Counsel for FIPUG is very involved in representing clients before the Florida Legislature. Thus, due to other pressing commitments related to legislative activity, FIPUG requests a very brief extension of time to file its brief.

3. FIPUG requests that it be permitted to file its brief no later than noon on Monday, March 5th. This short extension will not prejudice any of the parties and will not affect the other events scheduled in this matter.

4. Pursuant to rule 28-106.303(3), Florida Administrative Code, counsel for FIPUG has consulted counsel for FPL and counsel for Staff and is authorized to represent that neither FPL nor Staff object to this motion.
