ORDER APPROVING NAME CHANGE ON CERTIFICATE OF AUTHORITY

BY THE COMMISSION:

On February 20, 2012, ALEC, Inc., (ALEC) filed a petition requesting this Commission approve a name change on its Certificate of Authority No. 8402 from ALEC, Inc., to ALEC, LLC. ALEC attached a copy of the Florida Department of State, Division of Corporation's letter demonstrating that its name was changed with that Department on March 11, 2011, and that Department authorized ALEC, LLC, to conduct business in the State of Florida. In its petition, ALEC stated that it was not currently offering services in Florida, and that its tariff or price list will be filed with this Commission when it begins offering services in Florida.

We have jurisdiction over this matter pursuant to Sections 364.33 and 364.335, Florida Statutes.

Pursuant to Section 364.33, Florida Statutes, ALEC must have a certificate of authority to provide telecommunications services to the public in the State of Florida. ALEC must also provide written notification of and make a written request that this Commission approve changes to its Certificate of Authority.

Having reviewed the petition before us, we find that ALEC complied with Sections 364.33 and 364.335, Florida Statutes, in providing notification of and in the request for approval of its name change. We, therefore, find it appropriate to approve ALEC's name change from ALEC, Inc., to ALEC, LLC, on its Certificate of Authority No. 8402. ALEC, having changed its name, shall continue to comply with requirements of Sections 364.33 and 364.335, Florida Statutes, and must pay its regulatory assessment fees in accordance with Section 364.336, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that ALEC, Inc.'s request for approval of a name change on its Certificate of Authority No. 8402 to ALEC, LLC, is hereby granted. It is further

ORDERED that this docket shall be closed.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Office of Commission Clerk, and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
