Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code., Gulf Power Company (Gulf) requests confidential classification for certain highlighted information in its Environmental Compliance Program Update filed April, 2, 2012.

Staff has reviewed Gulf's confidentiality request. In staff's opinion, the request does meet the criteria for confidentiality contained in Section 366.093 Florida Statutes.
