Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company (TECO) requests confidential classification regarding the highlighted information contained in responses to staff's fourth data request, pgs 2, 3, 4, 7-11, and 14-15, filed August 1, 2012.

Staff has reviewed TECO's confidentiality request. In staff's opinion, the request does meet the criteria for confidentiality contained in Section 366.093 Florida Statutes.
