On July 19, 2012, AT&T Florida filed a request for additional numbering resources from the Number Pooling Administrator (NeuStar) for the Chipley exchange, Main (CHPLFLJADS0) switch. AT&T Florida requested 700 consecutive numbers in format of 850-NXX-1XXX, 6XXX, or 7XXX for a specific customer. On July 23, 2012, AT&T Florida's request for additional numbering resources was denied because it did not meet the utilization criteria.

On August 7, 2012, AT&T filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Commission Order No. PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the NeuStar code denials, staff has examined the AT&T Florida petition and has determined the following:

- 1) The carrier has demonstrated that it has customers in need of numbering resources;
- 2) The carrier has shown that it will be unable to provide services to these potential customers because of NeuStar's denial of the numbering resources; and
- 3) Customers will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three criteria of PSC-02-0352-PAA-TL have been met, please prepare an administrative Proposed Agency Action Order to be issued within seven business days of this memorandum (August 23, 2012), as outlined in the expedited code denial process order. NeuStar should be directed to provide AT&T Florida the needed numbering resources to meet its customer's needs in the Chipley exchange, Main (CHPLFLJADS0) switch.
