ORDER GRANTING TAMPA ELECTRIC COMPANY'S REQUEST FOR CONFIDENTIAL CLASSIFICATION AND MOTION FOR TEMPORARY PROTECTIVE ORDER FOR DOCUMENT NO. 01739-12

On March 23, 2012, pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company ("Tampa Electric" or "Company") filed a Request for Confidential Classification and Motion for Temporary Protective Order ("Request and Motion") for portions of Tampa Electric's Responses to Staff's Second Data Request Nos. 6 and 7. ("Response"). The Company asserts that the confidential information in the documents is intended to be private, is treated as private, and has not been publicly disclosed. Tampa Electric asks that the Commission grant confidential classification for the information for a period of at least 18 months. The Company also asks that we issue a temporary protective order pursuant to Rule 25-22.006(6)(c), Florida Administrative Code.

Request and Motion

Section 366.093(1), Florida Statutes, provides that "any records received by the Commission which are shown and found by the Commission to be proprietary confidential business information shall be kept confidential and shall be exempt from Section 119.07(1) [the Public Records Act]." Pursuant to Section 366.093(3), Florida Statutes, proprietary confidential business information includes information that is intended to be and is treated by the company as private, in that disclosure of the information would cause harm to the company's ratepayers or business operations, and has not been voluntarily disclosed to the public. Confidential business information includes, but is not limited to, the following:

- "Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms" and
- "Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." *Id* at (d)-(e).

Rule 25-22.006(6)(c), Florida Administrative Code, permits a utility to request a temporary protective order for information that is provided to the Office of Public Counsel ("OPC").

The Company argues the following with respect to the highlighted information contained in its Response at Bates pages 91 and 92: the information discloses names of entities or types of entities to whom Tampa Electric sells gypsum by-product; gypsum is an abundant by-product of the operation of power plant scrubbers; disclosure of the information could result in entities undercutting Tampa Electric's price and taking sales opportunities away from Tampa Electric resulting in harm to Tampa Electric's retail customers. The Company makes the additional argument with respect to the highlighted information contained in its Response at Bates page 92: the information details Tampa Electric's strategies for marketing gypsum by-product from scrubbers; disclosure of the information would be useful to those with whom Tampa Electric competes for the sale of gypsum by-products and would be detrimental to the Company's efforts to market this by-product resulting in an adverse economic impact on Tampa Electric's retail customers. Tampa Electric asserts that Section 366.093, Florida Statutes, and its implementing rule, are intended to protect against these types of harm.

Ruling

Upon review, I find that the information in Document No. 01739-12, described in the Request and Motion, is treated by the Company as private, has not otherwise been disclosed, and is information relating bids or contractual data, the disclosure of which would impair the efforts of the Company to contract for goods or services on favorable terms, and relates to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. I find that disclosure of the identified information would cause harm to Tampa Electric's ratepayers or to its business operations. Thus, the information shall be granted confidential classification pursuant to Section 366.093(3), Florida Statutes, and a temporary protective order pursuant to Rule 25-22.006(6)(c), Florida Administrative Code.

Based on the foregoing, it is

ORDERED by Chairman Brisé, as Prehearing Officer, that Tampa Electric Company's Request for Confidential Classification of information in Document No. 01739-12, described in the Company's Request and Motion, is granted. It is further

ORDERED that Tampa Electric Company's Motion for a Temporary Protective Order for such information contained in Document No. 01739-12 is granted. It is further

ORDERED that the information in Document No. 01739-12 for which confidential classification and a temporary protective order has been granted shall, subject to the requirements of Rule 25-22.006(6)(c), Florida Administrative Code, remain protected from disclosure for a period of 18 months from the date of issuance of this Order. At the conclusion of the 18-month period, the confidential information will no longer be exempt from Section 119.07(1), F.S., unless Tampa Electric Company or another affected person shows, and the

Commission finds, that the records continue to contain proprietary confidential business information. It is further

ORDERED that this Order shall be the only notification by the Commission to the parties of the date of declassification of the materials discussed herein.

the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.0376, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
