Windstream Corporation, on behalf of its incumbent local exchange carrier affiliates (hereinafter "Windstream"), hereby submits a revised Attachment 2 to its Election and Petition for Waiver submitted on July 24, 2012. Attachment 2 is a .csv file identifying, by 2010 Census Block FIPS code and wire center CLLI code, the 16,981 locations where Windstream will deploy broadband service in satisfaction of its requirements if the Petition for Waiver is granted. Windstream had previously submitted a version of Attachment 2 that did not include Census Block information, along with a request for a temporary waiver of 47 C.F.R. § 54.312(b)(3) and a commitment to submit such information when it became available.

Windstream submits the revised Attachment 2 pursuant to the Protective Order in CC Docket No. 01-92, WC Docket Nos. 05-337, 07-135, and 10-90 and GN Docket No. 09-51 (DA 10-1749, rel.
