Dear Mr. McDonnell:

By this letter, the Commission staff requests that Peace River Electric Cooperative (PRECO or utility) provide responses to the following data requests at the telephonic informal meeting on September 25, 2012, at 10:00 AM.

1. Do you have the necessary transmission and other facilities in place to provide transmission level service to Mosaic by November 2012?
2. If not, how long would it take TECO to be ready to provide service to Mosaic?
  - b. What facilities would PRECO need to install?
  - c. How much would it cost?
3. How would PRECO recover its cost to install facilities to serve Mosaic?
4. Does the territorial agreement between TECO and PRECO allow for a temporary variance to allow Mosaic to be served by TECO, but also cross into PRECO's territory?
5. Would PRECO have to purchase additional electricity from Seminole Electric to be able to serve Mosaic?
